Dr. Ann Marie Sullivan is currently Commissioner of the New York State Office of Mental Health, responsible for a large, multi-faceted mental health system that serves more than 800,000 individuals each year. The Office of Mental Health (OMH) operates psychiatric centers across the State, and also oversees more than 4,500 community programs, including inpatient and outpatient programs, emergency, community support, residential and family care programs.

As Commissioner, she has guided the transformation of the state hospital system in its emphasis on recovery and expansion of community based treatment, reinvesting over 90 million dollars in community services and redesigning the Medicaid benefit for the seriously mentally ill, embedding critical recovery services such as crisis respite, peer, educational and employment supports. She has expanded services for the mentally ill in prisons and in the much needed community based continuum of care for those leaving prison and returning to their community. As Commissioner she has expanded preventive services for children ages zero to five, spread across New York State First Episode Psychosis Teams, greatly expanded statewide Collaborative Care in Primary Care and improved Parity laws and accountability, including state approval of medical necessity criteria.
